

Prior Written Notice

When?

Prior written notice must be given to parents a reasonable time before the public agency proposes or refuses to initiate or change the:

- Identification
- Evaluation
- Educational placement
- Provision of a free appropriate public education (FAPE)



What?

- The prior written notice (PWN) is a vital component of parents' procedural safeguards.
- PWN communicates information from the public education agency (PEA) to the parents.
- PWN is a record of the PEA's decisions that have been made but have not yet been acted upon.
- PWN gives parents notice so they may seek resolution if they disagree with a decision.



Content

A PWN must include the following items:

- a description of the action proposed or refused by the school;
- an explanation of why the school proposes or refuses to take the action;
- a description of each evaluation procedure, assessment, record, or report the agency used as a basis for the proposed or refused action;



- a statement that the parents of a child with a disability have protection under the procedural safeguards provided in the IDEA and how a copy of those procedural safeguards may be obtained;
- sources for parents to contact to obtain assistance in understanding the IDEA;
- a description of other options considered by the IEP team and the reason why those options were rejected; and
- a description of other factors that are relevant to the school's proposal or refusal.




Language Requirements

- PWN must be written in language understandable to the general public.
- PWN must be provided in the native language or in the mode of communication used by the parent, unless it is clearly not feasible to do so.
- If the parent's native language or other mode of communication is not a written language, the school must take steps to ensure that the notice is translated orally and that the parent understands the content of the notice.
- The school must maintain written evidence that these steps were undertaken.









Initial Referral

- The purpose of this PWN is to outline for parents the decision to initially refer the child to the multidisciplinary evaluation team (MET) and the reasons for the referral.
- PWN is provided before the review of existing data.
- PWN comes before the evaluation begins.



Evaluation: Collection of Additional Data

- The first PWN for evaluation is required when the team has made a decision regarding the collection of additional data.
- The team must obtain informed written parental consent to collect additional data.
- PWN comes before any new evaluation data is collected.



Evaluation: Eligibility Determination

- The second PWN for evaluation is required when the team has determined whether the child is a child with a disability.
- The purpose of this PWN is to inform the parents:
 - Whether the child meets the criteria for a particular disability
 - Whether the disability is impacting the child's ability to successfully access the general curriculum
 - Whether the child needs special education and related services in order to make progress
- PWN is provided <u>after</u> the eligibility determination has been made.





Initial Placement

- PWN is required for initial placement in special education.
- For initial placement in special education, schools must obtain the parent's informed written consent before the delivery of any services.



Educational Placement

- PWN is required to document decisions about a child's educational placement along the continuum of alternative placements.
- PWN is required when a student exits special education altogether:
 - The multidisciplinary evaluation team (MET) determines the child is no longer eligible as a child with a disability.
 - Parents revoke consent for special education services.
 - Graduation from high school with a regular high school diploma or "aging out" of special education.
- PWN is required for disciplinary removals that constitute a change of placement.





Provision of Free Appropriate Public Education (FAPE)

- PWN is required before providing FAPE after an IEP has been developed or amended.
- PWN is required when the team has determined what constitutes special education and related services for this student.
- PWN is required when a parent requests additions or modifications to FAPE that the school refuses.





Provision of FAPE (continued)

- The purpose of the PWN is to outline for the parents the actions proposed or refused as a result of the IEP review and revision or amendment, such as:
 - Special education and related services
 - Measurable annual goals
 - Supplementary aids and services
- PWN must be given prior to the implementation of these decisions.









Activity
