

Arizona Report of Public Agency Performance on Racial / Ethnic Disproportionate Representation by Disability

Indicator 10: Racial / Ethnic Disproportionality by Disability

Percent of PEAs with disproportionate representation of racial and ethnic groups in specific disability categories that is the result of inappropriate identification.

Measurement

Arizona uses Statistical Analysis Software (SAS) to consider ethnicity by disability information to identify those public education agencies (PEAs) in Arizona that have unusually high rates of students (aged 6–21) in special education. The software compares the ethnic and disability makeup of the State to the ethnic and disability data of each PEA and provides a weighted risk ratio (WRR) for each PEA.

Arizona uses a WRR of ≥ 3.0 for over identification in determining if a PEA has disproportionate representation. Because Indicator 10 is concerned with disproportionate representation that is the result of inappropriate identification, the ADE reviews the policies, procedures, and practices of the identified PEAs to determine compliance with child find, evaluation, and eligibility requirements.

Data

The data are from school year 2015-2016. The table below indicates whether each PEA had a WRR ≥ 3.0 for any ethnic group and six disability categories. If the answer to that question is “yes”, the table indicates if the State determined that the PEA had inappropriate policies, practices, or procedures in identification.

State Target: 0% PEAs with disproportionate representation that is the result of inappropriate identification.
