# A. Education Organization

- 1. Get a local education agency
- 2. Get a school

## B. Staff

- 1. Get a Teacher (for future scenario)
- 2. Create Staff non Teachers e.g. substitute or coach

## C. Scheduling

#### (1) COURSE SCENARIOS

- 1. Create Course Offerings
- 2. Modify a course offering for a course that has a title change (local)
- 3. Delete a course offering that is no longer offered (beginning of year)

#### (2) CLASS PERIOD SCENARIOS

- 1. Add a section to a course
- 2. Delete a class period
- 3. Modify a class period that changed from period 1 to period 6
- 4. Change the course for a section

#### (3) SECTION SCENARIOS

- 1. Add a section
- 2. Add student in a section with
  - Student start date
  - Student End date
- 3. Exit a student from section and assign a grade mark

#### (4) TEACHER SCENARIOS

- 1. Add a primary teacher to a section
- 2. Add primary teacher start date
- 3. Add primary teacher end date
- 4. Change primary teacher start date
- 5. Change primary teacher end date
- 6. Change teacher assigned to a section
- 7. Add secondary teacher to section with a primary teacher
- 8. Add a start date to a secondary teacher
- 9. Add an end date to a secondary teacher
- 10. Change teacher assigned to a section





## D. Student & Responsible party

- 1. Add a new student
- 2. Add a Responsible party
- 3. Add an association to the student and a responsible party
- Modify a student's ethnicity

## E. Student Enrollment

#### (1) SCENARIOS FOR SECONDARY SCHOOLS

- 1. Enroll a student in a high school
- 2. Add a valid membership FTE and Tuition Payer code
- 3. Add a DOR
- 4. Withdraw a student
- 5. Enroll a student in a high school Second Semester
  - (i) Create a student section association for student at the HS
  - (ii) Create a student section association for student to enroll in the same course in a different section at the HS in the middle of the semester
  - (iii) Create a student section association for student to withdraw from one course

#### (2) SCENARIOS FOR ELEMENTARY SCHOOLS

- 1. Enroll a student in an elementary school
  - (i) Create a student section association for student at the Elementary school
  - (ii) Withdraw the student
  - (iii) Re-enroll the student to verify the ExitWithdrawaDate is less than the EntryDate of the subsequent record at the same school for the same student
- 2. Enroll a student with Special Enrollment as "Open Enrollment" and DOA = DOR

#### (3) SCENARIOS FOR AOI SCHOOLS

- 1. Enroll a Student in AOI School
  - (i) Add an attendance event for an AOI student
  - (ii) Add attendance minutes for a student in an AOI school
