Measurement

Percent of respondent parents who reported the school facilitated parent involvement as a way to improve services for children with IEPs, divided by the total number of respondent parents of children with IEPs, times 100.

Data

The data are from school year 2014-2015 The source of the data is a 25–question Arizona Parent Survey. Each school year a new cohort of public education agencies (PEAs) is selected to administer the survey. Every parent within those PEAs who has a child with an IEP is given the opportunity to complete the survey through a Web-based system or mail.

A PEA is listed with an asterisk (*) when it had fewer than 10 students with disabilities enrolled that school year. In these instances, the data are not reported to ensure confidentiality.
