HELP! Where to Find It

Confused about who to call for assistance when working with Funding Applications, Reimbursement Requests and Completion Reports? Not sure if the challenge is programmatic or system related—within Grants Management System (GME) or ADEConnect? GME offers support to users through system validations and user guides housed in the GME Document Library, but there may be times when those resources do not easily resolve the issue at hand. User Access
