## GME Help is Just a Click (Or Two) Away

The good news is there is a first line of assistance available to all GME users that doesn't require a phone call or email. Help is just a few clicks away in the Grants Management system **Document Library**, accessed from the GME main menu, where you will find numerous GME User Reference Guides.

The GME **Document Library** also houses past webinars and previous issues of Grants Management Connection, enabling you to stay up to date on all resources provided through the year.

For moments when direct assistance is needed, the Grants Management team is available to you by phone at **(602) 542-3901** or via email at <u>Grants@azed.gov</u>. Our email address is a great resource when something appears in GME that doesn't make sense to you, such as an unclear error message or the dreaded "Unexpected Results..." message. Take a screen shot of what you see and send it directly to us at <u>Grants@azed.gov</u>, so we can get to work resolving any issue you may be having.

Please don't hesitate to let us know how we can better help you, as we continue to develop better tools for all GME users for the purpose of improving educational support for Arizona's communities.

#### GME News You Can Use

Are either of these scenarios applicable to you?

- Your district/organization has changed or will be changing your email domain, resulting in a change of email addresses for all users.
- You have had a name change, which resulted in a change of email address.

If so, it is important to remember there is a relationship between your email address/ User ID in ADEConnect and GME. When changes occur, keep the following in mind:

- Email address(es) must be identical in both ADEConnect and GME, requiring updates to both systems in the event of changes.
- If ADEConnect is updated first, rather than GME, users will not be able to access the Grants Management system.
- Email address updates in ADEConnect may need to have the "Grants Management" relationship (permission) added back by your Entity Administrator for that system. Contact ADESupport at (602) 542-7378 if assistance is needed.
- ADEConnect changes require up to 24 hours to sync with GME. Please plan accordingly so you are prepared for a small amount of time without access to GME.

Stay tuned for future information on this topic! The Grants Management and ADESupport teams are working on user guidance to facilitate a seamless email change process.
