 - AzEDS Student Analysis Tool Phase I released!
 - A user who normally runs the STUD15 or the STUD10 for Student School Enrollment, FTE, Tuition Payer and Special Enrollment information and the ELL10, SPED10, SUP10, and SUPP11 while analyzing data for a single student can use this tool to see all the current data for these different areas on a single screen.
 - Still to Come in Future Releases Integrity Tab, ADM Tab, transactions posted by resource type and more.

API 3.0 High Level Scope

1. Ed-Fi 2.1



Elevates the platform to the latest Ed-Fi release along with associated benefits and fixes.

2. Calendar



Reduces redundancy for LEAs by replacing the need to input calendars into both SIS and separately into Enterprise. Calendars can be entered into SIS and submitted via AzEDS.

UPDATE – Calendar changes due to Ed-Fi 2.1 changes only; Enterprise will continue to be source for calendars in FY18 – in sandbox no later than June 2017 with go-live by January 2018

3. Link Membership to DOR

Creates Student School Association (Membership) and Student Education Organization Association (DOR) relationship.

 Tightens up the data relationships for a student enrollment to improve data integrity and impacts to downstream ADE applications that rely on this data (in FY17 the relationship is derived)

API 3.0 Scope – Calendar Update

- Calendar in AzEDS API 3.0
 - Implement calendar REST API changes in AzEDS 3.0, but leave it read-only
 - There WILL BE Data Schema Changes to support Ed-Fi 2.1
 - School Level Calendar mapping is required to support Ed-Fi 2.1
 - Private Day School calendars will be set up for each LEA in FY18, ADE will make a copy of Private Day School calendars in Enterprise for each associated LEA
 - FY17 Q3, Q4 development
 - Sandbox 3.0 deployment February 23, 2017
 - Production deployment July 1, 2017
- ❖ AzEDS System of Record for Calendar FY19
 - No REST API changes
 - Change REST API security to allows LEAs to submit calendars
 - Implement calendar rules & reports
 - Implement calendar correction work flow for School Finance
 - Vendor Support for calendar submission via API
 - Sandbox deployment July 2017
 - Prod deployment January 2018



API 3.0 Scope – Known Issues and Update

QA Complete

- EndOfCourseAssessmentCodeType field in courseOfferings resource has been made optional.
- REST API allowed student post even without a valid Student Unique ID,
 which is fixed in the new release.

In Progress:

- GetByExample with invalid StudentId brings all records back for that district. This is an Ed-Fi bug.
- LocalCourseTitle and LocalCourseCode are not available in course transcript resource.
- Researching Performance issues with sandbox

Calendar

- LEA data entry via the Enterprise Calendar Web Application is obsolete
- Submission via REST API from SIS calendar
- Submission using calendarDates API resource
- Still working out some requirements with School Finance such as
 - Submission Period
 - Reports
 - Integrity Rules



API 3.0 Scope – Student Association

REST API Changes

student SchoolAssociationLocalEducationAgencies


- New resource replaces studentEducationOrganizationAssociations
- In current version of the API, studentSchoolAssociations and studentEducationOrganizationAssociations are unrelated and that causes data integrity issues for downstream applications
- New resource will have a reference to studentSchoolAssociation, thereby improving data integrity
- Allows for associating one or more funding Ed Org IDs to an Enrollment, similar to FTE or TuitionPayer

915s for AzEDS



- Approval process to enable LEA to submit a 915s
- Due to Ed-Fi Schema changes, FY17 915s will need to be submitted through API v2.3; then moving forward should not have to support two versions

AZEDS KNOWN ISSUES & STATUS



AzEDS Known Issues List SAMPLE

- Integrity known issues:
 - SPED Rules 40044, 40061, 40067, 40057 all fixed and ready to be released (holding a couple days to ensure Data Push for February is complete first)
 - Drop Out Recovery rule 80028, some are students are failing even with correct data Target 2/23
 - Membership Rule 10081, students who re-enroll in same school Target 2/16
 - A handful of students are impacted by bugs with following rules –
 10120, 20017 Target 2/23
- Fed SPED additional existing rules will be included in the Fed SPED de-duplicated student count In progress, by 2/23 at latest
- ADM Interval issue for students having gaps between enrollment dates (QA started; target early March)
- SPED72 display issue, additional incorrect schools displaying in dropdown
 Target 2/16



AzEDS Report Performance Plan

- 1. Establish baseline- COMPLETE, ongoing
- 2. Upgrade AzEDS Database Servers to SSD improves I/O; will see some improvement after this change IN PROGRESS
- 3. Reports classified into 2 categories approach *can be* executed in parallel:
 - Daily Integrity, ADM
 - Real Time Verification and Transaction Reports
