 - Size and scope of equitable services
 - Proportion of funds allocated for services
 - Method for determining poverty data (Title I only)
 - Equitable services to teachers and parents
 - Thorough consideration of the views of private school officials regarding use of a third-party contractor(s) for services.
 - Will Title IA funds be pooled or be allocated by site
 - When will services be provided?
 - How the LEA will provide written notice including analysis and rationale of any consultation topic where the LEA and private school disagree.
