Pursuant to Title 2 CFR Part 200 Subpart F, Audit Requirements for Federal Awards, the Arizona Department of Education (ADE) requires ALL ENTITIES who receive federal funds pass-through ADE to complete an annual **Evaluation** Form. The completed form will need to be returned via email Singleaudits@azed.gov (ADE Grants Management) no later than December 18, 2017. It is imperative that all federal funds expended by your agency be listed, regardless of whether those funds are pass-through ADE or another source.

SINGLE AUDIT and FORM SF-SAC REMINDER NOTICE:

The Single Audit Act Amendments of 1996, under the guidelines of Part 200 Subpart F, Single Audit Requirements, states that a sub-recipient must contract an independent auditor for a Single Audit if federal fund expenditures meet or exceed \$750,000 within a fiscal year. Per Uniform Guidance 2 CFR 200 Subpart F Single Audit Requirements the sub-recipient is required to submit the single audit results to the Federal Clearing House (https://harvester.census.gov/facides/account/login) within thirty (30) days of receiving the audit report or nine months after the end of the auditee's fiscal year end and required by ADE to send the Single Audit Reporting Package to SingleAudits@azed.gov unless a longer period has been agreed to in advance. For example, entities with a fiscal year end of June 30, 2017, an electronic copy of your single audit must be emailed to SingleAudits@azed.gov or Grants@azed.gov no later than March 31, 2018.

Please remember to prepare and submit an Audit Evaluation (to ADE only), Single Audit (if applicable-to ADE) and Form SF-SAC or reporting package (to the Federal Clearing House) each fiscal year. For non-compliance and non-submission, ADE can impose the following sanctions:

- Withhold a percentage of Federal awards until the audit is completed satisfactorily
- Withhold or disallow overhead costs
- Suspend Federal awards until the audit is completed; or Terminate the Federal award
