WHAT IS THE ESA PROGRAM?

ESA is an account administered by ADE that is funded by state tax dollars to provide educational options for qualified Arizona students. By opting out of the public-school system, parents can seek a range of alternative educational services, such as private school or home-based education, to tailor an individualized educational plan that is best for their child. Qualifications are based on the most recent legislature and subject to change annually. Parents can apply under the following categories:

- K-12 Student with Disability
- Preschool Student with Disability
- Active Military
- Legal Guardian is Legally Blind, Deaf or Hard of Hearing
- Attends a D or F Rated School
- Resides within Indian Reservation
- Sibling of Qualifying Applicant
- Ward of Court

HELPFUL HINT WHEN REGISTERING YOUR ACCOUNT IN THE PORTAL.

While working to assist an applicant in registering their account, we discovered a solution to an error. Applicants received an error; "invalid character in name" when trying to register their email to create an account. After some light troubleshooting, we discovered that the applicant had a "." in their name.

If someone signs up with Jr. or W. for an initial, it will give the error when attempting to register their account. The resolution to this problem is to remove the period ("."). You may do this by calling an ESA Specialist.

EXPENSE REPORT DUE DATES

Expense Reports for Quarter 3 are due in the office on March 20th. The Quarter 4 Expense Reports are due in the office on June 20th. These can be sent electronically, dropped off or mailed in. They must be in the ESA office on or before the 20th.
