If extracurricular are going to be paid for with ESA funds, they should be through a public school. This does not mean that the student should be formally enrolled in public school; rather it means that if the school allows ESA students to participate in any extracurricular activities, those activities should be paid for with ESA funds. An example would include participation on sports teams.

For tutoring or teaching services, we realize that some courses previously identified as extracurricular should remain available to families as they are part of a traditional public school education. The following list includes subjects that would be available to ESA participants as long as proper credentials for the facility or instructor are provided (an accredited facility OR instructor's bachelor degree or higher or teaching certificate).

- Music Class (group or individual) and Instrument Rentals
- Foreign Language Class
- Physical Education (P.E.) inclusive of dance classes, gymnastics, group fitness. *Gym Memberships will NOT be allowed as they cover more than a class.
- Art Class (consumable items cannot be purchased separately from the class)
- Computer Science Class
- JTED equivalent courses in technical or career related topics
- Health Class
- Driver's Education Class

For students with disabilities there is a category in the statute (A.R.S. 2402 (4)©(iii)) for vocational and life skills education which can in some cases be beneficial for students. Credentials are still required for the course that would be counted as vocational or life skills and should be reviewed by ESA before utilizing ESA funds. An example would include a water safety course.
