DIRECTLY CERTIFYING PARTIAL MATCHES

It is important to declare all Partial Matches in CNP Direct Certification as either a "Match" or "No Match" prior to organizing and counting household applications.

What is a Partial Match?

A Partial Match is a student that didn't show up as a 100% match in CNP Direct Certification.

Partial matching can potentially reduce the total number of applications on file and will help ensure an accurate sample size of applications that are subject for Verification.

• Reminder: SFAs are required to review and accurately make a decision regarding students' match status using the Partial Match confirmation.


Begin by clicking on the Partial Match link displayed in the Results column.

Understanding Partial Matches

There are no set criteria when certifying a Partial Match as a "Match" in CNP Direct Certification and determinations are made on a case-by-case basis for each student.

• Reminder: If the Partial Match cannot be confirmed as a "Match", it is important to declare the student as a "No Match".

If the wrong partial matching determination has been declared by the SFA, this can be changed at any time by following the same steps listed above.

• Best Practice: Take the online training, Step by Step Instruction: How to Directly Certify a Partial Match found in the <u>ADE Online Training Library</u> prior to declaring any Partial Matches.

All Partial Matches certified as a "Match" by the user will receive the same benefits as students reported back as a "Match" in CNP Direct Certification.

 Reminder: This includes free meal benefits and the requirement to extend free meal benefits to household members for SNAP, TANF, and FDPIR matches.

Partial Matches certified as a "Match" must be entered to the Benefit Issuance Document (BID) as free and increased eligibility benefits must be implemented no later than three operating days from the date CNP Direct Certification was complete. Parents should be promptly notified of approval of benefits.



SFAs are expected to come prepared for the Preparing for Verification Workshop by certifying all Partial Matches and updating the BID prior to arrival.
