Program Description, Coherent Sequence, and Certification Information

The Environmental Service Systems program is being discontinued. No new Environmental Service Systems programs may be added for the 2018-2019 school year. The final year a district may offer an Environmental Service Systems program will be the 2019-2020 school year. The Environmental Service Systems program has been determined to not be eligible for JTED funding. The program will continue to be eligible for CTE Federal Perkins and CTE State Priority funding for the 2018-2019 and 2019-2020 school years.

#### PROGRAM DESCRIPTION

### **Environmental Service Systems**

The Agriculture, Food and Natural Resources (AFNR) Career Cluster Content Standards provide Arizona agricultural education leaders and educators with a high-quality, rigorous set of standards to guide what students should know and be able to do after completing a program of study in each of the AFNR career pathways.

The **Environmental Service Systems** (ESS) Career Pathway encompasses the study of systems, instruments and technology used to monitor and minimize the impact of human activity on environmental systems. Students completing a program of study in this pathway will demonstrate competence in the application of principles and techniques for the development, application and management of environmental service systems in AFNR settings. In addition to the required technical skills, students will also develop leadership, advanced employability, critical thinking, applied academic and life management skills. The program utilizes a delivery system made up of three essential and required components: formal instruction, experiential education through Supervised Agricultural Experiences (SAEs), leadership and personal development through the Career and Technical Student Organization FFA.
