#### PROGRAM DESCRIPTION

The **Nursing Services** program prepares students to perform routine nursing-related services to patients in hospitals or long-term care facilities under the training and supervision of a registered nurse or licensed practical nurse. The Arizona State Board of Nursing must approve Nursing Assistant Training programs which includes approval of the required RN instructor and required program coordinator.

The **Nursing Services** program is designed and delivered as a coherent sequence of school-based and work -based supervised learning. The **Nursing Services** students develop leadership, social, civic, and career skills through participation in the Career and Technical Student Organization **HOSA** (Future Health Professionals).

The **Nursing Services** instructional program prepares students for entry-level employment, further training, and/or post-secondary education for these and other occupations: Certified Nursing Assistant (CNA), Licensed Nursing Assistant (LNA), Patient Care Technician, Patient Care Assistant, and Caregiver
