Seal of Personal Finance Overview

A.R.S. §15-260 establishes the State Seal of Personal Finance Proficiency Program

This program recognizes high school students who have attained a high level of proficiency in Personal Finance at the time of graduation

Proficiency determined by completion of a set of State Board of Education Approved Tasks

Seal is placed on diploma and noted on transcript



Getting Started

Districts or Charter can choose to participate

Designate a Program Coordinator

Fill out an Intent to Participate Form (on webpage) Must be submitted by October 1st of the school year

Program Eligibility

01

Graduate from an Arizona district or charter school

02

Complete requirements during high school

03

Complete all Social Studies courses with a G.P.A of 3.0 or better out of a 4.0 scale

04

Complete 1 activity from each of the 4 categories

Passage of an assessment
Completion of an approved personal finance program
Participation in a co-curricular or extra curricular program
College and/or Career Readiness Plan
