Dear Director Slauter:

The Arizona Department of Education Audit Unit has conducted an audit of the Tucson Youth Development/ACE Charter High School (School) Average Daily Membership (ADM) for fiscal years 2016, 2017 and 2018. The purpose of the audit was to address whether the School properly reported student enrollment, and to determine if it received the correct amount of Basic State Aid.

Auditors determined that the School had incorrectly reported the enrollment data of 71 students, which resulted in its ADM being overstated by 2.57. As a result, the School was overfunded by \$14,415.34 which the School must repay to ADE. Additionally, auditors determined that the School failed to properly maintain some required documentation in student cumulative files.

We appreciate the cooperation and assistance provided by the School's administration during the course of the audit.

### **INTRODUCTION AND BACKGROUND**

The Arizona Department of Education (ADE) Audit Unit has conducted an Average Daily Membership (ADM) audit of the Tucson Youth Development/ACE Charter High School (School) pursuant to Arizona Revised Statutes (A.R.S.) § 15-239. This audit focused on whether the School properly reported enrollment data to ADE and received the correct amount of Basic State Aid for fiscal years (FY) 2016 through 2018.

*Average Daily Membership audits of district and charter holder funding*—Pursuant to A.R.S. § 15-239, ADE may conduct ADM audits, which help ensure the appropriate distribution of Basic State Aid provided annually to school districts and charter schools. School districts and charter schools receive Basic State Aid based on several factors related to student enrollment and attendance. To receive funding, school districts and charter schools report enrollment and attendance data to ADE. ADE processes that data, determines payment amounts according to the relevant statutory funding formulas and distributes payments to schools up to twelve times each year.

The ADM audit process determines whether payments were correct or if an adjustment is needed. The audit process compares the school district's or charter school's information reported to ADE's student data system to information found on the original records kept at the school. If auditors find that the school district's or charter school's reported information does not match the original documentation, the audit will calculate and report the funding adjustment needed to the school district's or charter school's Basic State Aid. These funding adjustments can be positive or negative, depending upon the audit findings. The audit findings are written and compiled into a report that is then issued to the audited entity.

*Superintendent's legal notice links the audit and appeals processes*—In addition to the report, the audited entity receives The Notice of Audit Findings and Required Reimbursement (Notice) that details the audit findings and determination of the Superintendent of Public Instruction (Superintendent) regarding adjustments to be made to the school district or charter school pursuant to A.R.S. § 15-915. The audited entity may appeal the Superintendent's decision in the Notice.

*Opportunity to appeal the audit*—A.R.S. § 41-1092.03 provides the audited school district or charter school that disagrees with the Superintendent's decision in the Notice with the opportunity to file a formal appeal within thirty (30) days after the report was issued. If an appeal is filed, the school district or charter school and ADE may reach agreement in an informal settlement conference. If an agreement is not reached at the informal settlement conference, the appeal will be adjudicated by the Office of Administrative Hearings.

*Funding adjustment process and timeframes*—When the Notice is finally settled or adjudicated, if ADE has determined that a school district or charter school received an incorrect amount of Basic State Aid, A.R.S. § 15-915 directs that corrections to schools' funding be made in the current budget year. In case of hardship, schools may request that the Superintendent allow a correction to be made partly in the current budget year.

*School information*—The School, located in Tucson, Arizona offered instruction in grades 9 through 12 and operated two high schools in fiscal years 2016, 2017 and 2018 and operated a Dropout Recovery Program in fiscal years 2017 and 2018. Table 1 presents the School's unaudited student, staffing and financial information for fiscal years 2016, 2017 and 2018.

## **SCOPE AND METHODOLOGY**

The audit focused on whether the School accurately reported its data to ADE and received the correct amount of Basic State Aid in accordance with statutes, the Uniform System of Financial Records (USFR) and its own policies and procedures for fiscal years 2016, 2017 and 2018.

To conduct this audit, auditors used a variety of methods, including examining School and ADE records to review 263 of 2,211 students over the three fiscal years audited. Adjustments to ADM are based solely on those identified students that the auditors evaluated further and are not extrapolated to create findings for the entire student population. Auditors also reviewed state statutes and School policies and procedures and interviewed School management and staff. Specifically:

- **Enrollment data** Auditors reviewed student schedules, enrollment histories and attendance data to determine if the enrollment data reported to ADE was correct. Auditors compared the entry and exit dates to determine if an adjustment was necessary. Auditors also reviewed absences to ensure that they were reported correctly and made adjustments if they were needed.
- **Dropout Recovery Program (DRP)** Auditors reviewed written learning plans, monthly progress indicators, and enrollment histories to determine if DRP enrollment data reported to ADE was correct. When DRP enrollment was incorrect, auditors made an adjustment.
- *Student files* Auditors reviewed student files to ensure that they maintained required documentation such as birth certificates, immunization records, and supporting residency documentation. Auditors identified files that did not contain all the documentation that was required to be kept in them by statute and ADE guidelines.
- *FTE calculations* Auditors reviewed the bell schedules and student schedules to determine whether the School reported the correct full-time enrollment (FTE) data to ADE. Auditors calculated the FTE based on the classes and time a student was enrolled in the School and compared the FTE to what was reported to ADE. When the FTE was incorrect, auditors made an adjustment.
- *Instructional hours* Auditors reviewed the bell schedules and calendars for the School for fiscal years 2016, 2017 and 2018. The total instructional hours offered for each grade met the minimum required by statute for each of the three fiscal years audited.

The Audit Unit expresses its appreciation to the School's administration and staff members for their cooperation and assistance during the course of the audit.

# FINDING 1: THE SCHOOL DID NOT ACCURATELY REPORT SOME STUDENT DATA, RESULTING IN AN OVERPAYMENT \$14,415.34

Auditors determined that the School inaccurately reported the student data for 71 students for fiscal years 2016, 2017 and 2018. Specifically, auditors found that 31 students had an incorrectly reported FTE, 16 students attended the School but were not funded, 14 student had incorrect enrollment dates and 10 DRP students were not funded correctly according to enrollment and monthly progress. As a result of these errors, the School's ADM was overreported by 2.57 and the School was overfunded by \$14,415.34 in Basic State Aid for the three fiscal years audited which the School must pay to ADE pursuant to A.R.S. § 15-915.

#### The School inaccurately reported some student data

The School inaccurately reported 71 student's enrollment data to ADE, which resulted in the School's ADM being overstated by 2.57.

According to A.R.S. § 15-901, for a high school student to be reported as a 1.0 FTE, the student must be enrolled in at least four courses which meet at least 123 hours annually each and total at least 720 instructional hours for the year. A student who does not meet these requirements is considered a part-time student and their FTE status must be reduced based on the number of actual instructional hours provided and courses enrolled<sup>1</sup>. In addition, according to ADE External Guideline and Procedures GE-17 and A.R.S. § 15-901, with the exception of pre-enrolled students, the enrollment dates for a student are the first day of actual attendance and the last day of actual attendance or excused absence. A.R.S. § 15-901.06 states the monthly participation in a dropout recovery program shall be recorded on or before the tenth school day of each month. However, the School did not always adhere to these requirements. Specifically, for the students that were sampled:

- 31 students had an incorrect FTE reported. As a result, the ADM for the School was overreported by 4.60.
- 16 students attended the School but were not reported and funded as being enrolled in the School. As a result, the ADM for the School was underreported by 6.75.

<sup>&</sup>lt;sup>1</sup> Pursuant to A.R.S. § 15-901, a full time student (1.0 FTE) in grades 9 through 12 must be scheduled for and attending at least 720 hours of instruction and at least four courses each of which meets for at least 123 hours annually; a 0.75 FTE student must be scheduled for at least 540 hours of instruction and at least three courses each of which meets for at least 123 hours annually, a 0.50 FTE student must be scheduled for at least 360 hours of instruction and at least two courses each of which meets for at least 123 hours annually and a 0.25 FTE student must be scheduled for at least 180 hours of instruction and at least one course which meets for at least 123 hours annually.

- 14 students were reported with incorrect enrollment dates. As a result, the ADM for the School was overreported by 3.22.
- 10 students had incorrect DRP enrollment reported. As a result, the ADM for the School was overreported by 1.50.

As shown in Table 2, data reporting errors resulted in an ADM overstatement of 2.57 for the three fiscal years audited.

#### The School failed to comply with statute and ADE guidelines

The School did not follow statute and ADE guidelines when calculating and reporting student FTE or student enrollment data.

Auditors determined that 31 of the School's students did not meet the statutory and ADE guideline requirements for full time enrollment (FTE). The FTE that was reported for these students was not correct based on the number of courses the students were enrolled in. As a result, the School overreported the FTE for the 31 students.

Additionally, auditors determined the School misreported the enrollment data of 30 students. According to ARS § 15-901, the first day of membership for continuing or pre-enrolled students shall be defined as either the first day a student physically attends school or the first day that classroom instruction is offered, provided that such students physically attend school within the first ten school days. For all other students, the first day of membership shall be defined as the first day a student physically attends school within the school days. For all other students, the first day of membership shall be defined as the first day a student physically attends school. The School incorrectly reported the entry or exit dates of 14 students and 16 students were not reported to ADE that did attend.

Finally, auditors determined that the School misreported the enrollments of 10 DRP students. Auditors identified some students that attended the DRP program but were not reported as DRP students. Furthermore, auditors identified some students that did not have all of their monthly progress reported to ADE. Students in a DRP program must be reported to ADE as DRP students and monthly progress must be reported to ADE for all months enrolled for each DRP student.

The School should review its reconciliation practices to ensure that its staff properly review the reports produced by ADE's System and reconcile them to the School's SMS data to identify any discrepancies that would affect funding and correct any errors identified. In the future, the School must ensure it complies with statute and ADE guidelines to properly calculate and report FTE and report student enrollments.

#### The School was overfunded by \$14,415.34

Auditors determined that the School did not receive the correct amount of Basic State Aid due to the inaccurate student data reported to ADE for fiscal years 2016, 2017 and 2018. The student data incorrectly reported by the School resulted in its ADM being overstated by 2.57. As a result, the School was overfunded by \$14,415.34 in Basic State Aid, which ADE must recoup from the School. Table 3 shows the ADM and funding adjustments required for the School for fiscal years 2016, 2017 and 2018.

#### **Recommendations:**

- 1. The School must repay to ADE \$14,415.34 in Basic State Aid due to incorrectly reported student data.
- 2. The School must ensure that it properly calculates and reports students' FTE and enrollments pursuant to statute and ADE guidelines.
- 3. The School must enter monthly progress indicators for all months a student was enrolled in the DRP program.

# FINDING 2: THE SCHOOL DID NOT PROPERLY MAINTAIN SOME STUDENT RECORDS AS REQUIRED BY STATUTE AND GUIDELINE

Auditors determined that the School did not properly maintain residency, birth certificate and immunization documentation for some students as required by statute and ADE guidelines. The School did not properly maintain required documentation in some of its student cumulative files. In the future, the School should properly maintain these documents to ensure compliance with statute and ADE guidelines.

#### The School did not properly maintain student file documentation

Auditors determined that the School did not maintain residency documentation for nine students as required by statute and ADE guidelines. According to A.R.S. § 15-802 and the ADE Arizona Residency Guideline, school districts and charter schools are required to maintain verifiable documentation of Arizona residency. This documentation must be provided each time a student enrolls in a school district or charter school and reaffirmed during the annual registration process. The ADE Arizona Residency Guideline identifies an approved list of options a parent or legal guardian may provide to the school district or charter school to meet these requirements.

Auditors also determined that the School did not maintain birth certificate documentation for two students as required by statute. According to A.R.S. § 15-828, a photocopy of the student's birth certificate or other reliable proof of the student's identity and age must be placed in the student's file.

In addition, auditors determined that the School did not maintain immunization documentation for one student as required by statute. According to A.R.S. § 15-872, "A pupil shall not be allowed to attend school without submitting documentary proof to the school administrator unless the pupil is exempted from immunization pursuant to section 15-873."

The School did not maintain the proper documentation required by statute and ADE's residency guideline. Of the 60 students sampled, nine of the student files did not have the proper residency documentation, two did not have a birth certificate and one student did not have immunization record documentation. Table 4 lists the student file documentation maintained by the School for fiscal years 2016, 2017 and 2018.

In the future, the School must ensure that it complies with statute by collecting and maintaining in each student's cumulative file copies of verifiable residency, birth certificate documentation and immunization documentation as required by law.

#### **Recommendation:**

1. The School must comply with statute and collect and maintain in each student's cumulative file copies of verifiable residency, birth certificate and immunization documentation as required by law.

A.R.S. § 15-915 requires that ADE makes corrections for audit findings to both budget capacity and state aid. ADE's School Finance Unit's Memo 13-011 informs LEAs of these statutory requirements:

A.R.S. §15-915, as amended by Laws 2012, Chapter 357, Section 3, requires the superintendent of public instruction, when it is determined that state aid or budget limits have been calculated in error, within the prior 3 years, to make corrections to budget limits and state aid in the current year. (Hardship application may be approved by the superintendent). Effective for audits initiated during 2016 and continuing in subsequent years, corrections for audit findings to both budget capacity and state aid (when applicable) will be made.

*Basic State Aid adjustment of \$14,415.34 required to be paid to ADE*—Auditors identified an overall funding adjustment of \$14,415.34 for the three fiscal years audited due to inaccurate student enrollment data.

Table 5 lists the ADM adjustments and the associated Basic State Aid adjustments for the School for fiscal years 2016, 2017 and 2018.
