- Determine to what extent the governing authority creates and monitors the strategic plan.
- Determine to what extent the school leadership team executes the strategic plan effectively.
- Determine the school's ability to demonstrate compliance with regulation.


Monitoring Handbook Format

- Monitored areas
 - Governance
 - Academic Program
- Aligned to the CSP application
- Breakdown by area
 - Elements
 - Multiple Indictors
 - List of possible artifacts to support the indicators
 - Leveled status descriptors for each indicator

Governance Elements

- Element 1 The governing authority creates and monitors the strategic plan as outlined in the Logic Model.
 - Strategic Plan
 - Organizational Structure
 - Process to Obtain Quality Leaders
 - Succession Plan for Board Members and Key School Leaders
- Element 2 Regulatory and Fiduciary Compliance

Monitoring Handbook Review



Logic Model

- Review your Logic Model.
- Focus on the Outcomes section.
- Brainstorm a list of artifacts that could be presented as evidence of implementation for the short- and medium-term outcomes.
- Be prepared to present your list, including a rationale for evidence selection.

Governance Monitoring Process

- Governance Fiduciary monitoring Element 2 occurs by January of first project year.
- Governance Strategic Plan monitoring Element 1 occurs in the Spring of the second project year.
- Scheduled onsite visit, usually lasting two hours.
- Principal/school head should be available during the visit.
- Documentation reviewed to determine status of each indicator.
- Risk Assessment is completed based on results.
