11 Desert Choice Schools - Evans Learning Center: Temperature logs for food storage areas are not being maintained for the month of August 2019. Discussed requirements for maintaining food storage area temperature logs, sample templates, and who would be responsible. Temperature logs for food storage areas must be maintained for 6 months.
