The <u>SEI Budget</u> - <u>Comprehensive</u> application is entirely housed within Grants Management Enterprise (GME) for FY2021. Be sure to change the drop down year to 2021 and search for SEI Budget - Comprehensive. You will find nothing for FY2021 under the former name, SEI Budget.



Our office has begun the process of evaluating the submitted SEI Budget Comprehensive funding applications. WE will only be reviewing those submitted by the deadline of May 15, 2020. No LEA appeals will be accepted, however, if a revision is required, we may contact you to edit your application before we are able to approve all or part of your request.

Our target for all approvals is July 1, 2020. You will be notified of your award, if any, between March 18, 2020 and July 1, 2020.

Please keep in mind that you must enter your budget request amount **after offsets** in the Budget page (Object and Function Codes). Do not budget the "before offsets" amount of your request, as you will not be funded for the amount of offsets shown on the **LEA Offsets Worksheet**.

It is crucial that your justifications for funding requests include the number of daily minutes of required targeted ELD instruction that each FTE or portion of FTE requested will be providing to ELs.
