2 Paid lunch prices were not adequately increased as required by the PLE tool. Upon review of the AFR from Fiscal year 2018 & 2019, it was concluded that Queen of Peace did not have a \$0 balance as of 1/31/2018 and therefore is not exempt from the PLE requirements.
