



### AZELLA Testing 2020 – 2021 Important Dates

#### Prior to any Placement Test Training and Test Administration

**REQUIRED** – The **Assessment Test Coordinator and Security Agreement** for School Year 2020 – 2021 must be completed with all required signatures and submitted to ADE’s Testing Inbox – [Testing@azed.gov](mailto:Testing@azed.gov)

**REQUIRED** – The **AZELLA Test Security Agreement** for School Year 2020 – 2021 must be signed by AZELLA staff and kept with the AZELLA District Test Coordinator

**REQUIRED** – Complete the **English Language Proficiency Assessment Administrator Attestation** for **all** AZELLA staff and retain it in the EL Monitoring notebook.

#### Time Frame 2020 – 2021 AZELLA Placement Test

**July 6, 2020 (opens)** **Understand Scoring** Training and Qualifications for the Kindergarten Placement Test Administrator and Stage II Writing Scorer. **A new account for School Year 2020 -2021 must be created.** Key Word = **2021azella** (case sensitive)

**July 13, 2020 (opens)** **REQUIRED** – AZELLA Placement Test Training modules available ONLINE through Pearson’s AZELLA Training Management System (TMS).

**August 17, 2020 (in accordance with the Executive Order)** Ordering additional Kindergarten and Stage II Placement Test materials and adding additional PAN users in **PearsonAccess<sup>next</sup> (PAN)** once the AZELLA DTC’s PAN account has been enabled by ADE.

**August 17, 2020 (in accordance with the Executive Order)** Student Placement Test registration is available in **PearsonAccess<sup>next</sup> (PAN)** after the AZELLA DTC’s PAN account has been enabled by ADE.

**In accordance with Governor Ducey’s Executive Order for the “first day of school for in-person learning”**  
The Administration of the AZELLA Placement Test may begin in accordance with Governor Ducey’s Executive Order for the “first day of school for in-person learning,” provided that all pre-testing requirements have been completed and students have been registered for the Placement Test in PAN.  
This test is administered **throughout the school year** as needed. The KPT and Stage II Placement Tests are paper-pencil tests; Stages III – V Placement Tests are online tests.

**April 30, 2021** Last day to order additional KPT and Stage II Placement Test materials.

**May 14, 2021** **Last day** for Placement Test administration, key-entering responses and scores for KPT and Stage II Placement Tests and submitting all Stages of tests for scoring.

Schools need to assess new potential EL students’ English proficiency and identify non-proficient students as English Learners as soon as practicable and well before the parent notification deadline.

When a district/school **receives Title I and/or Title III funds**, then mandated testing must be completed and parents notified of the students’ results within 30 calendar days from the start of the school year or within 2 calendar weeks of a student enrolling at a school.

If a school **does not receive either Title I or Title III funds**, then mandated testing must be completed and parents notified of the students’ results within 60 calendar days from the start of the school year or within 30 calendar days of a student enrolling in the school.

January 7, 2021	Student data extract for Grades K-2 Spring 2021 Reassessment Test and Grades K-3 2021 SAFT Pre-ID Labels and pre-registration for all students in PAN.
January 18 – March 19, 2021	<b>REQUIRED</b> – AZELLA Reassessment & SAFT Training modules available ONLINE through Pearson’s AZELLA Training Management System (TMS).
January 21, 2021	AZELLA District Test Coordinator’s PAN account is enabled for the Spring 2021 AZELLA Reassessment Test and the SAFT administration after verification of completed required trainings.
January 25 – 29, 2021	Test Materials Delivery Window for <b>Stages I and II Reassessment Test and Grades K-3 2021 Field Test</b> .
January 29 – March 5, 2021	Additional orders for <b>Stages I and II</b> Spring 2021 Reassessment Test and <b>Grades K-3 2021 SAFT (1/29 – 3/19)</b> Materials.
February 1 – March 19, 2021	<b>Spring 2021 AZELLA Reassessment Test administration window.</b>
