2 Meal count totals by category for the month of review were not correctly combined and recorded for breakfast. This was deemed a nonsystemic error and contributed toward fiscal action calculations.

Upon review of the BIC rosters, it was determined that the SFA had not claimed 1 classroom's rosters on 2/12 and 4 classroom's rosters on 2/17. In discussion with the SFA, it was determined that the oversight of counting these classrooms occurred due to the rush of an early release day and training of a new back-up manager. This was determined to be a nonrecurring and therefore a non-systemic problem.

The notification for termination of benefits for failure to respond was sent on 11/5/2019 while the due date given in the notification letter was 11/15/2019.
