

## 915 for FY20: Technical Impact and File Specifications

### AzEDS 915 process for FY20 using REST API 5.0

- REST API submission window for FY20 was closed on July 15<sup>th</sup>, 2020. To request the FY20 data correction LEAs should follow the 915 process. Please click [here](#) to know more.
- For FY20 there are two resource types:
  - Resources with a Student Id (provided in .csv file)
  - Resources without a Student Id (provided in 915 request letter)
- For resources with a Student Id please use the .csv file format mentioned in this document below.
- For resources without a Student Id please mention them in the request letter (List of resources available are given on page 2).
- After the LEAs get an approval from School Finance, the REST API window will be opened for corrections to the resources on the .csv file or in the letter.
- The AzEDS REST API 5.0 for FY2020 will ONLY accept the data based on the .csv file for student id resources and list mentioned in request letter for resources without student id.
- Integrity and ACE will run nightly for submitting LEAs during your approved open window.

## External File Format Requirements for resources with student id

### **File Type: .csv**

(a .csv - comma-separated values - file stores tabular data (numbers and text) in plain text. Each line of the file is a data record. Each record consists of one or more fields, separated by commas. The use of the comma as a field separator is the source of the name for this file format).

Please note:

- Values containing a comma (,) should be enclosed by quotes “ ” ex. (“School, Central City”)
- Order in the .csv file may vary as long as the *Headers* matches the content

### Column Headers:

- **FiscalYear**

Allowed types: Numeric

Restrictions: Length 4

Required: Yes

Validated by ADE during processing: Yes

Fiscal Year for the requested 915 changes. All rows in the file must have the same Fiscal Year.

- **StudentUniqueld**

Allowed types: Alphanumeric value

Required: Yes

Validated by ADE during process: Yes

- **Schoold**

Allowed types: Numeric

# ADE Quick Reference Guides



Required: Yes

Valid SchoolId for the 915 student data correction record

SchoolId must be the Entity Id and not the CTDS number.

- ResourceName**

Allowed types: Alpha (A-Z only)

Restrictions: Must be on lookup list (see list below)

Required: Yes

Validated by ADE during process: Yes

- PropertyLocator**

Allowed types: Value must contain letters between A-Z only

Required: Yes

Property of the Resource for which the values are to be changed

- OldValue**

Allowed types: Variable Character

Required: No - **Can be blank depending on change \***

Original value of the **PropertyLocator** [column]

- NewValue**

Allowed types: Variable Character

Required: No - **Can be blank depending on change \***

New value of the **PropertyLocator** [column] *\*Both cannot be blank for same Resource*
