Official Notice of Pupil Withdrawal Form Audit to begin in the 2020-2021 School Year

ADE Accountability will be working with our Title I Program in the completing audits on the "Official Pupil Withdrawal Forms". A link to that document, which includes "Guidance and Procedures", can be found <u>here</u>. Using the proper withdrawal codes ensures the accurate reporting of graduation, drop-out, and persistency rates. This audit is based on statues A.R.S. § 15-239 (A)(1), A.R.S. § 15-827 (A), (B), A.R.S. § 15-1042 (H) and direction from the United States Department of Education. We will be including scenarios based on incoming questions and common misconceptions in the Grader over the next few months.

Misconception: A school may withdraw a student with a "W1" code if they have a verbal statement from a parent, teacher, or neighbor of the student stating where the student will be attending school.

Clarification: A school <u>can only</u> use a "W1", or one of its sister codes, under the following scenarios with proper documentation:

WI, SI, W2I, S99 Transfer.

- Request for student records from a receiving public or private high school or an educational program (that culminates in a regular high school diploma).
- Written record of a response from an official in the receiving school or program verifying or acknowledging the student's enrollment.
- Report from AzEDS indicating other enrollment in an Arizona High School (i.e. Dropout Tracker report).

The documentation that accompanies the "W1" code would need to be available if your school were chosen for an audit.

Audits will not begin until we have gathered additional information from the field regarding practices and field's understanding of the withdraw form. Additional information will be sent prior to audits being conducted.
